Users of the New Zealand Companion Animal Register (NZCAR) accept the following terms and conditions:

1. "Customer" means the person who purchases the services offered by the New Zealand Companion Animal Register, its owners or agents.
2. "Registration Fee" means the fee paid to register a single animal onto the database.
3. "GST" means goods and services tax chargeable in accordance with the Goods and Services Tax Act 1985.
4. "Login" means any access by agents or clients for additions or updates to the New Zealand Companion Animal Register database.
5. "NZCAC" means the New Zealand Companion Animal Council, as well as the NZCAR stakeholders, related members and trusts.
6. "Animal Register Limited" means Animal Register Limited (ARL), its subsidiary companies, and directors, officers, employees or agents.
7. Use of the NZCAR is subject to these terms and conditions, the privacy policy and the liability statement, and customers accept these as part of registration.
8. Animal Register Limited, as managers of the NZCAC, has the discretion to accept or decline registrations without reason, further the NZCAC and/or ARL reserve the right to cancel any registration without notice should the need arise.
9. No costs are payable to access your ARL customer records or to browse the open parts of the web site. Customers are responsible for any costs incurred in registering an animal onto the system regardless of whether it is later found that the registration is legal or illegal.
10. Animal Register Limited may, at its absolute discretion, suspend or terminate the access of any Customer at any time and for any reason.
11. The NZCAR will be available online 24/7, subject to server accessibility and accepting there may be minor outages. Animal Register Limited will also be contactable during office hours of 8am to 5pm, using email, our 0800 number and/or by visiting our offices.
12. All attempts are made to keep information secure and we advise reading our privacy policy in this regard.
13. NZCAC and Animal Register Limited have attempted to provide a web site that is both complete and offers a full Animal Recovery Service. Every effort has been made to ensure all content is legal and free from copyright. Any increase or decrease in the registration fee shall take effect from the time of implementation and shall not be applied retrospectively to any fees already paid.
18. The prices of all services are displayed in New Zealand currency.
19. The prices of the services listed on the website are exclusive of GST, unless otherwise specified.
20. The provision of the Companion Animal Register is limited in liability and customers are advised to read the limitation of liability statement on the site.
21. Customers shall pay for the services offered by cheque, eft-pos, credit card, direct credit or bank transfer. Cash transactions are not recommended and no liability for lost money will be accepted.

The animal contact shall be the sole party responsible for ensuring that information stored in the NZCAR is current and accurate. It is the contact's responsibility to notify the NZCAR of changes to these details.

The animal contact shall acknowledge and agree that registration with the NZCAR is not a guarantee that the animal will be returned, nor does it guarantee or make any warranty on the condition of the animal at the time of recovery.

The NZCAR disclaim any responsibility for the costs incurred in the recovery of an animal and the animal contact shall assume total responsibility for arranging for the return of the lost animal and any costs incurred.
